- Kiser vs. Kamder Ohio Case
- Ohio Dentist endodontist
- Advertise as endodontist but not limit practice
- Ohio State Dental Board rules advertise as specialist must limit practice to specialty services
- Kiser filed suit challenging OSDB rules 1st and 14th Amendments
- District Court dismissed Kiser's claims.
- 6th Circuit Court of Appeals reversed the District Court August 5, 2016



Sixth Circuit:

- Revered District Court and Remanded
- Truthful non-misleading information Kiser is a general dentist and endodontist
- Not false, misleading, or deceptive
- Kiser properly alleged a violation of his commercial speech rights

Ohio State Dental Board

 November 2016 – filed amended rules allowing a specialist who advertises specialty status to practice outside scope of specialty

ADA

- October 2016 HOD amended Principles of Ethics and Code of Professional Conduct
- Bottom-line: specialists no longer must limit their practice



- Texas Case
- US Court of Appeals for Fifth Circuit
- Plaintiffs AAID, American Society of Dentists
 Anesthesiologists, American Academy of Oral Medicine,
 American Academy of Orofacial Pain and 5 Texas
 licensed dentists
- Defendants Texas State Board of Dental Examiners (Texas Society of Oral and Maxillofacial Surgeons as intervenor-defendant)



- Texas law prohibits "false, misleading, or deceptive advertising in connection with the practice of dentistry"
- Texas State Dental Board enacted Rule 108.54:
 - A "dentist may advertise as a specialist or use the terms `specialty'
 or `specialist' to describe professional services in recognized
 specialty areas that are:
 - (1) recognized by a board that certifies specialists in the area of specialty; and
 - (2) accredited by the CODA
- The Rule then lists the nine specialty areas recognized by the State Dental Board, which track those specialty areas recognized by the ADA.



- Trial court invalidated Texas rules
- US Court of Appeals for the Fifth Circuit June 2017
- Upheld trail court's decision
- 5th Circuit said Texas Dental Board failed to show that consumers would be harmed by Plaintiffs advertising as specialists



- What does it all mean?
- Bottom-line
 - Specialists who hold themselves out as specialists no longer must limit practice – OSDB rules & ADA
 - Concerns referrals Marketplace
 - Specialists may still advertise "practice limited to"
 - For now, OSDB rules still recognize only the nine ADA specialties
 - dental public health; endodontics; oral and maxillofacial pathology; oral and maxillofacial radiology; oral and maxillofacial surgery; orthodontics and dentofacial orthopedics; pediatric dentistry; periodontics; and prosthodontics.
 - Board now considering alternatives



- Future of Specialty advertising and recognition?
 - Ohio State Dental Board is considering alternatives:
 - 1. 9 ADA recognized specialties only
 - ADA gold standard reformed specialty process 2017-18
 - 2. American Board of Dental Specialties 2014 American Board of Oral Implantology, American Board of Oral Medicine, American Board of Orofacial Pain, and American Dental Board of Anesthesiology.
 - 3. Completion of CODA-accredited post-doctoral education program (CODA-accredited dental residency)
 - 4. No regulation of dental specialties or advertising (Wild West)



Fifth Circuit

- "We do not suggest that the [Texas Dental] Board may not impose appropriate restrictions in the area of dental specialist advertising. The plaintiffs agree that advertising as a specialist is potentially misleading and that reasonable regulation is appropriate. We hold only that the Board has not met its burden on the record before us."
- "The Board may satisfy its burden with empirical data, studies, anecdotal evidence, or history, consensus, and simply common sense."



Advocacy

- No Increased Taxes
 - ODA stopped proposals to impose additional taxes onto dentists
 - Stopped proposed provider tax
 - Stopped proposal to extend sales tax to certain dental services
 - Clear Tray Aligners
 - State budget bill FY 2018-19



Non-Covered Services

- Dental insurers setting fees for non-covered services
- NCOIL Model Legislation
 - Senate Bill 87 Introduced March 2017
 - House Bill 367 Introduced in October 2017



- Access to Care
 - Kellogg Foundation \$16 million
 - Universal Health Care Action Network Ohio (UHCAN-Ohio)
 - Ohio Legislation Senate Bill 98 (Sen. Peggy Lehner)
 - ODA Response:
 - Inadequate training for irreversible, surgical procedures
 - Diversion of resources
 - Stopped continued vigilance




UHCAN-Ohio

- Dental Therapists
- CODA accredited dental therapy program (3 years post high school)
- Diagnosis
- Treatment planning
- Restorative procedures
- Local anesthesia
- Simple extractions
- Supervise RDHs and DAs

 - Therapists practice in metropolitan areas


2017 Practice Locations of Licensed Dental Therapists in Minnesota

- Ohio Department of Health
 - Oral health as the number one unmet health care need in Ohio
- ODA and Dentistry
 - Long history of addressing access to care issues
 - Medicaid
 - OPTIONS, GKAS & Volunteerism
 - Use of auxiliary personnel EFDAs
 - Prevention
 - Education and awareness
- ODA Task Force on Access to Care and Auxiliary Utilization

House Bill 184

- Introduced by Reps. Theresa Gavarone (R-Bowling Green) and Tony DeVitis (R-Green)
- Passed the House of Representatives with overwhelming bipartisan support in October
 - Allows use of technology to extend care into underserved areas of Ohio
 - Creates the Primary Care Dental Student Scholarship component of the Choose Ohio First Program
 - Enhances the ability of dental auxiliaries to provide preventive dental services
 - Promotes licensure portability
- ODA Supports



- Adult Dental Medicaid Program
 - Ohio is one of 12 states with dental coverage for adults
- Medicaid Dental Reimbursements
 - Ohio 41st out of 50 states
- Medicaid Dental Reforms
 - \$16.5 million increased reimbursements denture repairs, extractions statewide, 5% increase across the board in rural counties – 2016-2017
 - Received the 5% increase: Columbiana County



- Ohio Dentist Loan Repayment Program Expansion 2017
- Medicaid Reform
- Delegable Duties Existing Dental Team
- Tele-dentistry
- Volunteer Programs GKAS, OPTIONS, etc.
- OSU College of Dentistry
 - OHIO Project
 - Expansion of class size
