There have been significant improvements in composite and adhesion technologies. Composites are often perceived as being so complicated/time consuming that many clinicians are apprehensive to incorporate them into practice. However, new technologies actually enable clinicians to place the majority of their direct composites in a highly predictable, repeatable and efficient manner with a simplified bonding and composite tech-

nique

This course will provide you with an arsenal of practical approaches to simplify direct resin placement while increasing the options available to you. Simplified placement translates into lower cost to the doctor to provide treatment and more efficiency in delivery time.

Development of metal-free alternatives for the restoration of posterior teeth has been driven by patient demand for improved esthetics. Advances in adhesive and resin technology are rapidly positioning composites as functional preferences in posterior treatment. New techniques and materials can allow clinicians to place posterior resin restorations faster, easier, more predictably and in a time comparable to amalgam restorations.

- Simplified shade mapping system to efficiently choose the value, shade and surface characteristics of any resin restoration.
- How to immediately dentin seal and resin coat dentin prior to composite placement.
- Techniques to simplify layering and achieve natural polychromicity in two shades or less.
- Three methods to determine the lingual contour and incisal position of Class IV composites.
- Proper preparations for Class-IV restorations.
- How to efficiently and predictably restore multiple Class II posterior composites.
- Master fast/ beautiful finishing/polishing
- Understand multiple uses for flowable composites.

Basic Principles in Pediatric Dentistry for the General Practitioner

From preventive, restorative and surgical procedures, to behavior guidance techniques and minimally invasive options for the pre-cooperative

niques and minimally invasive options for the pre-cooperative child, clinicians will learn basic principles in pediatric dentistry to assist in diagnosis and treatment planning.

- Define pediatric dentistry, early childhood caries, severe early childhood caries, and dental neglect.
- Components of an infant dental visit and identify aspects of preventive pediatric dentistry.
- Basic and advanced behavior guidance techniques.
- Describe the types of restorations and armamentaria needed for the treatment of primary teeth.
- Purpose and indications for pulp treatment in the primary and immature/mixed dentition.
- List indications for extractions and the armamentaria needed for pediatric dental surgical procedures
- Describe the purpose of space maintenance therapy
- Understand minimally invasive dental options for precooperative children such as SDF, Hall Crown, and Atraumatic Restorative Techniques

Excellence in Diversity and Inclusion from Patient Care to Team Leadership

Discuss diversity and inclusive excellence as an oral health care practitioner. Discussions around bias, stereotypes, and social justice will take place. Dr. Nadar Sharifi 'Uppers are from Mars, Lowers from Venus: Clarifying Overdentures'

Dentists can choose from four available options when treatment planning for a completely edentulous arch; denture, implant retained overdenture, implant supported overdenture and a fixed bridge. Complete dentures and implant retained fixed bridges are well understood, but the two intermediate overdenture options are confusing. I'll clarify the difference between the implant retained overdenture and the implant supported overdenture.

Indications for each option will be created for both the upper and lower arches.

Clarification of the overdenture answers one question, but poses another - how does attachment selection impact overdenture fabrication? Three attachment families to choose from in addition to rotational bars and non-rotational bars. All of these attachments have indications and contra-indications. Simplification for overdenture therapy.

Clinical pick up of an attachment under an overdenture is a challenging task full of potential errors. Review three excellent techniques and share clear guidelines when one should be selected over another. I'll introduce the Atlas of Overdenture Design that I've created and share those solutions for future reference and comfort with this treatment for all our patients.

Leave with increased confidence and a clear understanding of clinical treatment ideals, including the ability to:

- List the four restorative solution for treating an upper or lower edentulous arch
- Clarify the difference between implant retained & implant supported overdentures.
- Identify which three options dominate in the upper arch and the different three that dominate in the lower arch.
- Understand how implant location dictates attachment selection.
- Master the difference between resilient and non-resilient attachments.
- Review clinical protocols for intra-oral attachment pick up
- Getting the occlusion right easy delivery solutions
- Review different impression protocols and understand when each is indicated


This all-day course is geared toward general practitioners, prosthodontists, surgical dentists and lab technicians.

Treating Sleep Apnea in Your Practice; From Getting Started to Medical Billing

cover marketing, physician communication, basic treatment philosophies, appliance choices, medical billing and the financial and emotional impact on your practice and team. 
